TRAPT FUNCTION TERMS & CONDITIONS

We want you to have a great experience planning and organizing your function with us and a fantastic time during your event so here are a few things to keep in mind.

TENTATIVE BOOKINGS

Due to high demand, tentative bookings are not available. TRAPT requires full payment to confirm a booking. By making a payment, you agree to our terms and conditions.

MINIMUM SPEND

For full venue hire, TRAPT reserves the right to apply a minimum spend where the bar and lounge is specifically allocated for a function. This amount will be outlined upon email booking confirmation where applicable.

CANCELLATIONS

For full venue hire, cancellations within 14 days of the booking date will result in forfeit of a 10% deposit (unless otherwise determined by management). Once TRAPT has been able to re-allocate that booking date to another function/event, the deposit may be refunded.

Further pre-payments are refundable less any costs incurred by TRAPT before the booking was cancelled (i.e. catering costs).

PAYMENT

Full payment for Drinks Packages must be made upon arrival at your function/event unless prior arrangement has been made with management and confirmed in writing. If paying in advance, all funds must be cleared 48 hours prior to the function being held. Payments can be made online or via direct bank deposit.

Payments for Food Packages and Pizzas are to be settled with our suppliers directly. Please refer to their terms and conditions for cancellation and refund policies.

DURATION

TRAPT is licensed to 1am however all functions and events will end no later than 12:30am.

TRAPT MAY END A FUNCTION OR EVENT EARLIER FOR THE FOLLOWING REASONS

- Responsible Service Alcohol (RSA) not being adhered to
- Function naturally winding up
- Safety concerns
- At the manager's discretion

DECORATIONS, DISPLAYS AND SIGNAGE

All clients are welcome to decorate the function area. The client and/or organisers are financially responsible for damage caused to TRAPT property.

RESPONSIBLE SERVICE ALCOHOL (RSA)

TRAPT Management is required by law to obey government restrictions on the responsible service of alcohol.

It is TRAPT management, staff and security responsibility to monitor the supply of alcohol and insure guests are not intoxicated. The function or event may be terminated and deposit forfeited if the following laws are being breached by any guest

- Supplying liquor to a minor
- Supplying liquor to a person who has been cut off
- Any anti social behaviour towards other guests, patrons or staff
- Any destruction of property
- Any guest refusing to leave when requested
- All other relevant legislation

We encourage the host to work with our management, staff and security to insure all guests not only have a good time but also make it home safely.

CLIENT LIABILITY AND RESPONSIBILITY

The person(s) or organisation listed as the Client shall be liable for all the costs and charges as a result of the agreed booking. The Client is required to inform all relevant persons involved in the organising of the event/function of the terms and conditions. It is understood that the Client will be responsible to ensure the orderly manner of their guests. TRAPT reserves the right to exclude or eject any person from the event or function or premises without liability.

LOSS OR DAMAGE TO TRAPT PROPERTY

The Client and/or organisers are financially responsible for ANY damage or breakages sustained to TRAPT and/or equipment owned by, sub hired or supplied by TRAPT, by the client, organisers, guests or any other person attending the function or event. TRAPT will not accept any responsibility for the damage or loss of items prior to or after the function.

MINORS

Please keep in mind that we are a licensed venue and minors can only be on the premises and attend private functions if a responsible adult, who is either their parent or legal guardian, accompanies them. The venue would have to be notified prior to the event of any minors attending. The minors are not allowed to consume alcoholic beverages. The venue has the right to turn away any guest of a private function at the door if they don't provide a valid ID upon request, so please ensure everyone has their identification with them.

SECURITY

A security charge and bond may apply for some functions and events. In the case of security being required at a function or event, the cost of contracted security will be borne by the client.
